All residents of India fulfilling the eligibility criteria mentioned below can apply to RUHS CUET 2026 for admission to various Diploma and Undergraduate courses in constituent colleges, Government Colleges, Government Self-Financed Colleges and Private Colleges affiliated to RUHS, Jaipur (State Government Medical University), on the basis of instructions given in this information brochure, the relevant rules of RUHS, Jaipur and directions of State Govt. / Hon'ble Court.

For admission to Diploma and Undergraduate courses in constituent colleges and affiliated colleges to RUHS, Jaipur, it is mandatory to appear in the RUHS CUET 2026.

10. ELIGIBILITY FOR 10+2 RESULT AWAITED / SUPPLEMENTARY CANDIDATES

- ★ For online allotments, a candidate must have passed in individual subjects by the time of choice filling.
- ★ Candidates who are presently under “appeared (result awaited / supplementary) category” will be required to update their result at the RUHS website by the notified date, by entering through their login ID and password failing which their candidature shall stand cancelled or by following a procedure as may be informed at the RUHS website.

12. RESERVATION

12.1 The reservation of seats will be made subject to statutory provisions of Govt. of Rajasthan for Rajasthan domicile candidates. Candidates belonging to reservation categories of states other than Rajasthan shall be allotted seats in the unreserved category.

☞ Candidates will be required to submit the Valid Certificate (For SC/ST/OBC-NCL/MBC-NCL/EWS), if applicable, at the time of filling Online Application Form and at the time of joining allotted college to be considered under the category.

12.2 Defence

- ☞ 1% seats (In Government Colleges Only) are reserved horizontally on priority cum merit for the natural born (not adopted) sons / daughters of Defence Personnel (Serving / retired) of Rajasthan Origin, and Para Military personnel (Serving / retired) of Rajasthan origin (in ratio 3:1). 50% out of these reserved seats shall be reserved for girls, unfilled seats will be reverted to boys category.
- ☞ As per the Kendriya Sainik Kalyan Board, the defence seat is admissible for only one member of the family, once in lifetime. Only wards of Defence Personnel from Army, Air Force & Navy from serial 1 to 9 below are eligible for the scheme, priority order (certificate proforma 1) for Defence personnel of Rajasthan origin, will be as follows:
 1. Widows/Wards of Defence Personnel killed in action.
 2. Wards of those Disabled in action and boarded out from service
 3. Widows/Wards of those Defence personnel who died while in service with death attributable to military service
 4. Wards of those Disabled in service and boarded out with disability attributable to military service.
 5. Wards of ex-service men and serving personnel who are in receipt of Gallantry Award.
 6. Wards of ex-service men.
 7. Wives of (i) defence personnel killed in action and boarded out from service (ii) defence personnel disabled in service and boarded out with disability attributable to military services (iii) ex-servicemen and serving personnel who are in receipt of Gallantry Award
 8. Wards of serving personnel
 9. Wives of serving personnel
- ☞ As per the letter no. **F25/SKV/2022/13423-30 Dated 13.10.2022** of Sainik Kalyan Vibhag, Govt. of Rajasthan, the para-military seat is admissible for only one member of the family once in lifetime. According to the MHA (Ministry of Home Affairs), only wards of Para-military personnel from serial 1 to 3 below are eligible for the scheme.
- ☞ Priority order (certificate proforma 2) for Para-military personnel of Rajasthan origin, will be as follows:
 - ☞ Wards/ Widows /Wives of those Paramilitary personnel killed in action.
 - ☞ Wards/ Widows /Wives of those Paramilitary personnel permanently disabled in action and boarded out from service.
 - ☞ Wards of All serving and retired personnel.

12.3 PwD

5% seats within each category (horizontally) shall be reserved for candidates with specified disabilities (PwD) under the Rights of Persons with Disabilities Act, 2016 and in accordance with Appendix H-1 of Graduate Medical Education Regulation, 1997 of MCI as amended on 14.05.2019 (**Annexure 1**).

12.4 Female

The horizontal reservation to female candidates will be applicable as mentioned below.

1.	Female	Not less than 25% out of each category of SC, ST, STA, OBC NCL, MBC NCL, EWS and UR category shall be filled from female candidate.

Note: The percentage of female candidates shall not fall below 50% of total seats in B.Sc. Nursing admission.

12.5 Scheduled Tribal Area (STA)

☞ 45% of ST seats are reserved for ST candidates who are bonafide residents of scheduled area (tribal area).

- Note:**
- Candidates seeking benefit of reservation shall be required to produce for verification, at the time of joining at the allotted college, the original and valid certificate (SC, ST, ST-STA, OBC Non creamy layer, MBC Non creamy layer, EWS) or the additional category original and valid certificate (PwD, if applicable) issued by the competent authority and submit attested copies of the above documents.
 - OBC/MBC candidate must submit original OBC/MBC Certificate for Rajasthan State issued by competent authority of Rajasthan (issued within last one year of the date of conduct of the RUHS CUET 2026 and clearly indicating 'Non Creamy Layer') at the time of joining.
 - EWS candidate must submit original EWS Certificate for Rajasthan State issued by competent authority of Rajasthan (valid for financial year 2026-27) at the time of joining.
 - PwD reservation: 5% seats shall be reserved on Merit-cum-Priority in each category horizontally in accordance with Annexure 1. On the notified date, the PwD candidate must produce PwD certificate (issued by Competent Authority) during physical disability verification before the Medical Board constituted by RUHS, Jaipur for the purpose.
 - All reservation will be applicable only for Round 1 and Round 2 counselling process. During Round 3 and Open Round counselling, there will be no reservation applicable. All candidates will be treated as unreserved.
 - All reservations policies are applicable as notified by Government of Rajasthan from time to time.

13. DOMICILE CRITERIA

☞ Admission to the course is open to all residents of India. However, preference will be given to residents of State of Rajasthan.

14. MEDICAL FITNESS

☞ A candidate desirous of admission will have to deposit the medical fitness certificate at the time of joining to the allotted college on the prescribed form certified by a medical officer of the Government of Rajasthan as per the medical standards.

17. RUHS COMMON UNDERGRADUATE ENTRANCE TEST (RUHS CUET-2026)

- The common merit list shall be made strictly on the basis of score obtained in RUHS CUET-2026-27 and admission shall be made on the basis of merit and the order of choices / options filled online by the candidates.

- The candidates will be allowed to take along question paper/ OMR Carbon copy after completion of test.
- Admit card will be available for downloading at the RUHS website and not be sent by individual post.
- All candidates are required to appear in the RUHS CUET-2026 at their own expenses. No TA/DA will be paid to candidates for appearing in RUHS CUET-2026. The appearance in the RUHS CUET-2026 will not confer any right upon the candidate to be admitted in the prescribed courses of RUHS, Jaipur.
- Candidates trying to use unfair means shall be disqualified from the admission. Further necessary action (as applicable) will be taken by RUHS. No correspondence whatsoever will be entertained from the candidates.

19. CHOICE FILLING

- ☞ After declaration of RUHS CUET 2026 result the eligible candidates will be allowed to participate in the online counselling process.
- ☞ The eligible candidates will be required to fill choices of the course and college (in order of preference).
- ☞ Guidelines for filling the choices and making on-line payment of counselling fee will be available at the RUHS website in due course.

20. ADMISSION PROCEDURE

- ☞ The admissions shall be made strictly in accordance with merit list prepared on the basis of score of the RUHS CUET-2026 and the order of choices / options filled-in by the candidates on-line. The candidates are advised to exercise their choices / options very carefully.
- ☞ Candidates are advised to visit regularly RUHS website (www.ruhsraj.org) for updated information about admission process.

Important note: If at any stage, it is found that a non-eligible candidate is admitted to a course, then the admission of such a candidate will be cancelled on such detection. A penal action may also be initiated against such candidate.

21. ALLOTMENT OF COLLEGE AND COURSE

- ☞ The allotment of college and course shall be made by strictly following the order of merit, seats available in each college and the priority of choice/option of the college and the course filled-in by the candidate on-line.
- ☞ Provided that, in case of equal score in RUHS CUET-2026, the relative merit of Candidates shall be resolved in the following order of preference and methodology as specified below-

- (a) higher percentage of aggregate marks in PCB/PCM in 10+2 or equivalent examination;
- (b) higher percentage of marks in the Physics at 10+2 or equivalent examination;
- (c) higher percentage of marks in the Chemistry at 10+2 or equivalent examination;
- (d) One who has obtained higher marks in Secondary examination (10th) or its equivalent examination.
- (e) The candidate of higher age (older candidate).

☞ After allotment of college and course, allotment list will be declared on RUHS website. Candidate is required to take a printout of the allotment letter / information and join at the allotted college with this printout alongwith requisite documents, in original, and prescribed fee, by the notified date.

☞ The non-viewing of the RUHS website about allotment information by the candidate shall not be accepted as a ground for not submitting the option form or non-joining at the allotted college on the scheduled time and date. The candidate's allotment will stand automatically cancelled, if he/she does not report IN PERSON to the allotted college as per notified schedule.

22. JOINING AT ALLOTTED COLLEGE AND DEPOSITING OF FEES AND OTHER DOCUMENTS

22.1 Bachelor of Science Nursing (B.Sc. Nursing)

☞ At the time of joining at the allotted college, the candidate will have to carry printout of the allotment letter. The candidate is required to deposit the prescribed fee along with original documents and one set of attested photocopies of requisite documents. The colleges shall be provided the list of candidates allotted. The colleges shall verify the credentials of reporting candidates as per the allotment list and check the documents and other required certificates with originals.

☞ In case of non-reporting/non-joining by the candidates at the allotted college in round 1, candidate shall not be eligible to participate in subsequent round(s) of online counselling or as decided by RUHS.

☞ Candidates should fulfill the conditions related to bond (Wherever Applicable for Government Colleges/ Government Self-Financed college).

☞ In consonance with Govt. of Rajasthan letter no. P7(3) Nursing/DME/2014, dated 13/10/2020, the candidates allotted a seat in Government colleges/Government self-financed colleges will have to submit a bond in prescribed proforma amounting to Rs. 50,000 (Rupees fifty thousand). If the candidate leaves the course after second round of counselling (before completion of the course) due to any circumstances then such a candidate will have to pay Rs. 50,000 as penalty. Refer **Annexure 2** for Proforma of the Bond.

☞ In case of non-reporting/non-joining by the candidates at the allotted college in round 1, candidate shall not be eligible to participate in subsequent round(s) of online counselling or as decided by RUHS.

(b) B.Optom*., B.MLS*, B.RTT* and B.MRIT*.

- ☞ At the time of joining at the allotted college, the candidate will have to carry printout of the allotment letter. The candidate is required to deposit prescribed fee along with original and one set of attested photocopies of requisite documents.
- ☞ The colleges shall be provided the list of candidates allotted. The colleges shall verify the credentials of reporting candidates as per this list and check the documents and other required certificates with originals.
- ☞ In case of non-reporting/non-joining by the candidates at the allotted college in round 1, candidate shall not be eligible to participate in subsequent round(s) of online counselling or as decided by RUHS.

Note: In-service candidates must obtain relieving letter from their appointing authority before joining at the allotted college. In case of non-submitting the relieving order from the appointing authority by the last date of joining, the admission will automatically be cancelled.

22.3 Pharmacy (Diploma in Pharmacy and Bachelor of Pharmacy)

- ☞ At the time of joining at the allotted college, the candidate will have to carry printout of the allotment letter. The candidate is required to deposit the fee prescribed for the course along with original and one set of attested photocopies of requisite documents. The colleges (that are included in this admission/counselling process) shall be provided the list of candidates allotted. The colleges shall verify the credentials of reporting candidates as per this list and check the documents and other required certificates with originals.
- ☞ In case of non-reporting/non-joining by the candidates at the allotted college in round 1, candidate shall not be eligible to participate in subsequent round(s) of online counselling or as decided by RUHS.

23. ADMISSIONS ON THE VACANT SEATS, DROP-OUT SEATS

- ☞ After 2 rounds of on-line counselling, if seats remain vacant either due to exhaustion of the merit list or due to non-joining of candidates at the allotted college, RUHS reserves the right to take appropriate decision to fill the seats remaining vacant.
- ☞ It is clarified that colleges shall not fill any seat directly at their own level.
- ☞ No admission shall be made after the date as may be notified by RUHS.
- ☞ The admissions shall be treated as provisional subject to the final decision of any pending case(s) in any court of law, if applicable to these admissions. Further, the provisional status of admission shall be confirmed only after enrolment by the RUHS after document verification at the level of RUHS (documents as submitted by the candidate). Any circumstances-based decision relating to the admission/counselling process may be taken by the Chairman E & R Cell, RUHS or Chairman Admission/Counselling Board, RUHS which shall be final and binding on all concerned.
- ☞ All the judgments relevant to these admissions, passed by any Hon'ble court of justice as well as rules existing at the time of making admissions will be applicable on these admissions and the candidates will have to abide compulsorily with such judgments, rules and the changes.
- ☞ The decision of the RUHS shall be final and binding to all.

24. CANCELLATION OF ADMISSION AND REFUND OF FEES, RETURN OF DOCUMENTS BY INSTITUTIONS

- (a) The Candidate shall apply for cancellation of admission by submitting duly signed application to the allotted Institution before the start of last round of counselling process. The Institute shall consider the request made by candidate for cancellation as final. Upon such cancellation, the candidate shall lose the claim on the seat and such seat shall become available for further allotment. The Institute shall refund the fees to the candidate after deduction of Rupees one thousand only towards processing charges and return all his/her original documents submitted to the Institute within two days from submission of duly signed.
- (b) Candidate shall not be entitled to any refund of his/her fee except the Security Deposit / Caution Money Deposit if the cancellation is effected by the candidate after of the cut-off date by RUHS.
- (c) No institution, who has in its possession or custody, any document in the form of Certificates, Degree, Diploma or any other award or other document deposited with it by a person for the purpose of seeking admission in such institution, shall refuse to return such Certificate, Degree, Diploma, award or any other document with a view to induce or compel such person to pay any fee or fees in respect of any course or program of study which such person does not intend to pursue or avail any facility in such institution;
- (d) The Institution shall not entitle to recover the fees for the subsequent years from the student seeking cancellation of his/her admission at any point of time.

The apex court drew guide lines for the management of all educational institutions of all India. Among them:

Educational institutions should take anti-ragging measures right from the time of advertisement for admissions.

The information brochure, the form for admission and/or any other literature issued to aspirants for admission must clearly mention that ragging is banned in the institution and anyone indulging in it is likely to be punished appropriately which may include expulsion from the institution, suspension from the institution or classes for a limited period or fine with a public apology.

The punishment may also take the shape of:

- (i) With holding scholarships or other benefits
- (ii) Debarring from representation in events
- (iii) With holding results
- (iv) Suspension or expulsion from hostel or mess.

If there be any legislation governing ragging or any provisions in statute/ordinance, it should be brought to the notice of the students/parents seeking admissions. A printed leaflet detailing when and to whom a victim may turn for information, help and guidance for various purposes, keeping in view the needs of new entrants, along with their addresses and telephone numbers should be given to fresher at the time of admissions that they need not to look to seniors for help in such matters.
